

## **REPOSITIONING OF THE UNIVERSITY REGISTRY**

This is to inform the University community of the creation of additional positions for Deputy Registrars and the new nomenclature of the existing Divisions in the Registry of the institution as a way of repositioning this important administrative segment of the University.

Council, in its wisdom, at its meeting held on Friday, 05 October, 2018 noted and approved the proposal from the Registrar that the change became inevitable in the face of enormous responsibilities and increasing challenges of the 21<sup>st</sup> Century University Administration.

This was done for better service delivery, matching up with global developments and best practices in prestigious Universities in the world,

In this new dispensation, the former Academic Division has been split into two units and each headed unit is headed by a Deputy Registrar namely Deputy Registrar (Senate, Admissions and Affiliated Institutions) and Deputy Registrar (Examinations, Records and Admission Data Processing Unit (ADPU), while the Postgraduate College now has two Deputy Registrars namely the Deputy Registrar (Admissions and General Administration) and the Deputy Registrar (Examination and Records).

For the former Establishments Division, the new nomenclature is Human Resource and Development (Academic Staff) and Human Resource and Development (Non-Teaching). The disposition in the new Registry is shown below as at January 2019:
