## **OPTION B**

- ❖ IF YOU ARE UNABLE TO VOTE DUE TO SOME TECHNICAL REASONS, kindly visit the Voting Centre in the Trenchard Hall to cast your vote with a valid University identity card.
- ❖ Internet-ready computer systems will be available to assist you to cast your vote
- ❖ Having voted, you are expected to exit the Voting Centre **immediately.**

# **GENERAL**

- ❖ Voting shall not be by proxy.
- ❖ An accredited voter is only allowed to vote once.
- ❖ There shall be no campaign in the Voting Area.
- ❖ After voting is over, the candidates with the highest number of votes cast shall be declared the winner for the position.
- Any proven attempt to vote more than once/ subvert the election process shall be deemed as **gross misconduct** and treated accordingly.
- ❖ If it is discovered after the elections that any candidate who was not qualified to have contested, for whatever reasons won, such a result would be annulled and awarded to the candidate with the next highest vote for that position.
